	Tier 1 Entrepreneur Route	Tier 1 Investor Route
Which Tier 1 visa route is right for me?	For people setting up business and wishing to remain in the IOM.	For people making a qualifying investment who wish to remain in the IOM.
How do I apply?	Applications must be completed online at www.gov.uk/government/organisations/uk-visas-and-immigration and submitted via an overseas visa application centre.	
What happens next?	Applications received will be processed and sent to IOM Passport, Immigration and Nationality Office for a decision.	
What are the key criteria I have to demonstrate?	<ul style="list-style-type: none"> ● Access to £200,000 to establish, take over or join a business in IOM (Another partner can provide funds or funds maybe a loan). ● Applicants must be able to support themselves once on the IOM and be able to prove they have personal savings of at least £3,300. 	<ul style="list-style-type: none"> ● Access to £2m which is available to invest in the IOM within first 3 months.
How long is an initial grant of Tier 1 visa for?	The initial period of grant is for 3 years and 4 months.	
Who will issue the visa?	The overseas visa application centre.	
Can I extend the visa and if so, for how long?	An application to extend the visa for another 2 years can be made providing: <ul style="list-style-type: none"> ● At least £200,000 has been invested in one or more IOM business ● The applicant is self-employed or a registered director of the IOM business ● At least 2 full-time equivalent jobs existing for more than 12 months have been created. 	An application to extend the visa for another 2 years can be made providing: <ul style="list-style-type: none"> ● £2m has been invested in IOM trading companies (other than companies principally engaged in property investment) ● Investments must have been made during the first 3 months of arriving in the UK and the funds must have remained invested throughout the full period of leave to remain.
How can I qualify and apply for indefinite Leave to Remain in the IOM?	Applications must be made to the Isle of Man Passport, Immigration and Nationality Office. Applicants: <ul style="list-style-type: none"> ● Must have resided in the IOM for 5 years and ● The applicant can be absent from IOM or the UK for more than 180 days in each 12 month period without affecting their application for indefinite leave to remain – an applicant could spend 180 days in China and the remaining 185 days in any part of the Common Travel Area, including the IOM ● Must demonstrate a sufficient knowledge of English and life in the UK and Isle of Man. 	



Can I accelerate the process of gaining Indefinite Leave to Remain?	<p>Yes</p> <ul style="list-style-type: none"> ● The business has generated 10 or more jobs or business income of at least £5m within the 3 year period ● You can apply for ILR after 3 years if an IOM business has been taken over or invested in and net income has increased by £5m within the 3 year period. 	<p>Yes</p> <ul style="list-style-type: none"> ● If £5m invested instead of £2m, the time before you apply for ILR is reduced to 3 years or ● If £10m invested instead of £2m, the time before you can apply for ILR is reduced to 2 years.
What is position for my partner and children?	An application must be made for each dependent at the same time as the Tier 1 application is made. Adult children are not dependents and must apply for Tier 1 visas in their own right.	
Do I need any other permission to live and work in the Isle of Man?	A work permit under the Control of Employment Act 2014 maybe required.	No permit under the Control of Employment Act 2014 is required unless the applicant wishes to take up work.
